Instruction on Completing Application Form for Scientific and Technological R&D Award for Postgraduates (Not Studying in Macau)

The Application Form for Scientific and Technological R&D Award for Postgraduates is the basic document and primary basis of award assessment. It shall be filled out conscientiously and authentically in strict accordance with the instructions provided in this document.

The content shall relate to scientific research conducted during the period of pursuing graduate studies at higher education institutions outside Macao, as well as the research achievements obtained as a result.

The application form and its appendices only need to be submitted online through the application system. There is no need to submit hard copy materials.

I. Personal Resume

The content shall not exceed 800 words. Key points shall include main research work, participation in scientific research projects, scientific research achievements, and scientific value obtained.

II. Participation in Scientific Research Projects

Fill in according to the chronological order of participation in the projects.

III. Awards Received

List the awards in order of importance. Fill in “N/A” if not applicable.

IV. Representative Papers and Monographs

List the items in order of importance. Indicate in the notes if the concept of the corresponding author or first author does not apply to certain disciplines. Fill in “N/A” if not applicable.

V. Patent Application/Acquisition

List the items in order of importance. In addition to invention patents, such as computer software copyrights, integrated circuit layout design rights, and new plant species rights, any other types of intellectual property may be included. Fill in “N/A” if not

applicable.

VI. Appendices

1. Macao SAR Resident Identity Card: A scanned copy of a valid permanent or non-permanent Macao SAR Resident Identity Card shall be submitted. Only 1 PDF file is allowed.

Enrollment Certificate Issued by Higher Education Institution outside Macao: If the applicant is a current student, he/she shall submit scanned copies of the student ID card and enrollment certificate; if the applicant has graduated from a higher education institution within two years prior to the date of acceptance of the award application, he/she shall submit scanned copies of the graduation certificate, degree certificate, and degree confirmation document. Only 1 PDF file is allowed.

3. Intellectual Property Liability Statement: Please check “Agree” and confirm submission.

4. Reference Letter Issued by Thesis Advisor: For applicants in the master’s group, a scanned copy of the reference letter signed by the master’s thesis advisor is required; for applicants in the doctoral group, a scanned copy of the reference letter signed by the doctoral dissertation advisor is required. Only 1 PDF file is allowed.

5. Published Papers/Monographs: Submit the full text for each paper; and submit the cover, copyright page, core content pages and bibliography pages for each monograph. Only 1 PDF file is allowed for each paper/monograph.

6. Proof of Patent Application/Acquisition: Submit the full description document for invention patents, and submit the certificate or full description for other types of patents. Only 1 PDF file is allowed for each content.

7. Proof of Awards Received: Submit scanned copies of awards or certificates. Only 1 PDF file is allowed for each content.

8. Other Certificates: The certification materials that reflect the candidates’ contributions and objective appraisals. No more than 10 PDF files.
